I acknowledge that I shall receive no further compensation in connection with the Materials and Creative Product or the rights granted under this Consent and Release.

If my child is hired as a host for Kids' Pet Club, compensation and commitments will be agreed in good faith at that time.

I absolve the Producer of any and all liability in connection with the Creative Product.

I grant to the Producer complete discretion in how they edit and use the Materials. I acknowledge that Producer is under no obligation to use the Materials or to incorporate them in any Creative Product.
